- A. All on variety - ie. quartz, wood, agate, etc.
- B. Mixed Varieties - Several good specimen of different minerals.

### **DIVISION II: FOSSILS**

- A. All one of a kind fossil.
- B. Mixed specimens of fossil.

### **DIVISION III: LAPIDARY ARTS**

- A. Cabachons
- B. Faceting

### **DIVISION IV: EDUCATION**

Tools, books, machinery information or combination

### **DIVISION V: JEWELRY & METALCRAFT**

- A. Jewelry - personal items (necklaces, bolos, earrings, buckles, etc.)
- B. Metal Craft - wire wrapping, silver, smithing, trees, & goldwork.
