- I understand that the Pensacola Interstate Fair is NOT LIABLE in any manner for the tenant's property or damage/loss caused by burglary, theft, robbery, fire, water damage, mysterious disappearance or acts of God.
- I understand that the Pensacola Interstate Fair WILL NOT have security on the property. Gates WILL NOT be locked at night. Buildings will be locked.
- I understand that my booth location will be assigned to me and if I set up in a location different than what I am assigned I will be asked to tear down and move my booth.
- I understand that the Pensacola Interstate Fair will not provide any help/labor with loading and unloading my items and understand that there will be no one to help me and there will be no dollies and/or carts for me to use.
- I understand that if I close or tear down my booth before 4 p.m. each day I will not be allowed to return as a vendor.

Rules and Regulations

These rules are subject to change without notice.

- Hours of Operation:** Hours open to the public are from 9 a.m. till 4 p.m. every day. The facility will be open for check-in from 1-5 p.m. the day before the event or 7:00 a.m. all mornings of the event.
- Space Resale Rights:** Booths not occupied by 9 a.m. will be re-rented by management without notice to the seller/vendor and without refund to the seller/vendor.
- Space Boundaries:** All merchandise is to be kept within the allotted space rented. Failure to comply will result in dismissal with no refund.
- Cleanliness:** Sellers/Vendors are required to keep their space maintained and clean. It is the responsibility of the seller/vendor to remove ALL trash before leaving. Boxes should be broken down and flattened and placed in the dumpster, or behind the building **NOT** in garbage cans.
- Food and Beverages:** NO food or beverages may be sold without explicit permission from the Pensacola Interstate Fair grounds. You must adhere to all state and federal guidelines, i.e., cottage food rules.
- Parking:** Please leave the parking lots in front of the buildings open for customers' use. Vendors may park behind the buildings in an area that does not interfere with allotted outside booths. There will be no charge for parking.
- Trademarked/Counterfeit/Stolen Merchandise:** The sale, display or distribution of merchandise that infringes upon copyrighted designs or materials, bears counterfeit trademarks, or is stolen is strictly prohibited.
- Electrical:** Sellers/Vendors requiring electrical use will be charged \$5 and MUST indicate on their application that electricity is needed. No heaters, coffee pots or any electric appliances are allowed unless in a food truck/concession. Food Trucks charge for electric is \$25.00.
- Items Not Allowed:** There will be no selling of drug paraphernalia, guns, ammunition, pornography, fireworks, tobacco, E-cigs, Cigars or Vapor Products. No offensive books, T-shirts or materials are allowed. The Pensacola Interstate Fair grounds reserves the right at any time to prohibit any additional items from being sold or traded and to refuse admission to any seller.
- Laws:** Sellers/Vendors shall comply with all cities, county, state, and federal laws.
- Sound:** The Pensacola Interstate Fair grounds reserves the right to keep sound emitting from any type of stereos, radios, televisions, and/or any other sound to an acceptable level. Sellers/Vendors shall always conduct themselves in an acceptable manner.
- Minors:** Sellers/Vendors are responsible for their children and must be kept under control and in your space unless accompanied by an adult.

13. **Right of Entry:** Pensacola Interstate Fair grounds reserves the right to inspect all merchandise and always have access to a seller's space.
14. **Clean up:** Sellers/Vendors are responsible for the clean-up of their area at the end of the day. All garbage and trash boxes, etc. are to be placed in the dumpster, boxes broken down and flattened. **NOTHING** is to be left in your booth when you leave other than the rented tables.
15. **Liability:** Pensacola Interstate Fair grounds assume no responsibility for any items lost, stolen, or damaged while on their premises. The seller/Vendor agrees to hold Pensacola Interstate Fair grounds harmless from any liability or damage arising from seller's use of the premises and/or injury to person or property resulting from items sold or exchanged thereon. Seller/Vendor understands that Security for outside booths will not be provided, and gates will not be locked overnight. Buildings will be locked overnight.
16. **Insurance:** Sellers/Vendors should obtain adequate property, liability, and workmen's compensation insurance. Pensacola Interstate Fair grounds accepts no responsibility for loss to sellers/vendors for any reason. If the Pensacola Interstate Fair grounds are sued for any negligent acts of a seller/vendor, Pensacola Interstate Fair Grounds Insurance Company will subrogate against the seller/vendor for the full amount of loss paid.
17. **Right to Terminate:** The reservation of a seller/vendor constitutes an agreement by the seller/vendor to comply with ALL rules and regulations. Sellers must be at least 18 years old to reserve selling space. The Pensacola Interstate Fair grounds reserves the right to revoke the seller's reservation and evict rule violators.
18. **Sellers/Vendors** are allowed to leave merchandise overnight. However, the Pensacola Interstate Fair grounds cannot be held responsible for loss, theft or damage to the seller/vendor's property or items. Seller/Vendor understands that Security for outside booths will not be provided, and gates will not be locked overnight.
19. **Sellers/Vendors** must place all dangerous objects such as knives in cases or behind tables, so they are not accessible to the public.
20. **Sales and Solicitation:** No sales or solicitation are allowed in the parking lot or aisles. Do **NOT** solicit outside of your booth.
21. **Set Up:** Setup will be between 1 p.m. and 5 p.m. the day before the event and 7:00-9:00 a.m. mornings of the event. Please be considerate of others, unload/unhook your transport vehicle completely, move it out of the area, then complete your set up. The seller/Vendor understands that they will be asked to tear down and move if they set up in the wrong booth space.
22. **Tear down:** **No earlier than 4:00 p.m.** **Sellers/Vendors that tear down or close before 4:00 p.m. on any day will not be allowed to return as a vendor.** Again, please be considerate of others, complete your packing and tear down before moving your transport vehicle for loading.
23. **Rain or Shine:** This is a rain or shine event. No refunds will be given for any reason.
